- (b) whether it is also a fact that the funds were not released for 17 lac school students of the State under Mid-day Meal Scheme since August, 2017 by the Punjab Government whereby the guidelines of the Hon'ble Supreme Court have been violated;
- (c) the efforts being made by the Govt. to meet the deficiency of calories among the school children due to not serving the lunch under Mid-day Meal Scheme?
