- \*1724. **Shri Madan Lal Jalalpur, M.L.A.** :- Will the Chief Minister be pleased to state whether the Govt. would earmark budget for the year 2019-20 for shifting of Police Station, Ghanaur away to another public place which is near by bus stand?

**Details of vacant posts of Doctors in P.H.C Maloud and Payal**

- \*1778. **Sardar Lakhvir Singh Lakha, M.L.A.**:- Will the Health and Family welfare Minister be pleased to state:-  
 a) the details of vacant posts of doctors at present in P.H.C Maloud and Payal falling in Assembly Constituency Payal;

  - if not, the opinion of the govt. to carry out its desilt from Mallan wala road upto tail?


**Regarding per unit rate of power to consumers**
