To allot the Shops/Booths of Boha Grain Market to the Commission Agents (Arhtiyas)

7. Shri Budh Ram, M.L.A.:- Will the Chief Minister be pleased to state:-

- (a) whether it is a fact that shops (booths) have been constructed for the commission agents (Arhtiyas) in the grain market of Boha (Assembly Constituency Budhlada) but these shops have not been allotted to the commission agents (Arhtiyas) due to high cost of the same;
- (b) whether the Government proposes to allot the said shops (booths) to the commission agents (Arhtiyas)?

To rationalize the Teaching Staff of the Schools of Punjab

- 8. Shri Budh Ram, M.L.A.:- Will the Education Minister be pleased to state:-
- (a) whether it is a fact that the posts (of all categories) are lying vacant on large scale in the schools of Punjab but the teaching staff in the schools of big city Mohali and nearby Corporation cities is more than the required staff;
- (b) whether the Government proposes to rationalize the said posts so that the availability of teachers can be assured as per the proportion of students in remote area schools also?
