Four-laning the road from Goindwal Sahib to Taran Taran

*252. <u>Sardar Manjinder Singh Lalpura, M.L.A</u>:- Will the Public Work (B & R) Minister be pleased to state whether the government considers four laning the road from Goindwal Sahib to Taran Taran; if so, by when?

To open a Government College in Mukerian (Distt. Hoshiarpur)

*280. <u>Shri Jangi Lal Mahajan, M.L.A.:-</u> Will the Higher Education Minister be pleased to state whether there is any proposal under consideration of the Government to open a Government College in Mukerian (Distt. Hoshiarpur); if so, by when?
