## To set-up an Industrial Training Institute (ITI) at Village Rurka Kalan

- (a) whether it is a fact that the Government had approved the proposal to set up an Industrial Training Institute (ITI) at village Rurka Kalan in Phillaur sub-division;
- (b) the steps taken by the Government to start the said I.T.I. alongwith the time likely to be taken for the same?

### **Implementing the Provisions of the Mental Healthcare Act 2017**
