- a) whether it is a fact that a high level meeting of the Punjab Government had approved the draft of 'Punjab Public Library and Information Services Bill' but the Bill has not yet been introduced in the Vidhan Sabha despite the lapse of a long time;
- b) if reply to part (a) above be in the affirmative, whether the Government is considering any proposal in near future to enact as Act the Library Bill after passing it through the Assembly; if so, the time by which it is likely to be done?
