### **Eligibility**

1. The Company must be registered in India under the Companies Act 1956 / the Companies Act 2013 having its registered office in India or a Partnership Firm registered under the Partnership Act, 1932 or LLP firm registered under the Limited Liability Partnership Act, 2008.
2. The participating company must provide the Security Audit certificate from Indian Computer Emergency Response Team (CERT-In) empanelled auditors (Auditor name should be listed in "https://www.cert-in.org.in/PDF/Empanel\_org\_2022.pdf").
3. The participating company must be in Cyber security audit the at least 5 years prior to the issuance of the tender.
4. Annual turnover of the Participating company in the last three years should be on an average of 1 Crores.
5. Participating MSME Companies are exempted from Prior Turnover and prior experience.
6. Rate quotations (in a sealed and closed envelope) should be submitted to the Punjab Vidhan Sabha Secretariat, Chandigarh, on or before 16th December 2025, either through Indian Post or manually at the Punjab Vidhan Sabha Notice Office.
